This form allows the ticketed party to submit a formal, written objection statement, which will be reviewed, and may be granted or denied. If granted, the parking tag will be discharged. If denied, you will be notified of a hearing date and time at which may present your objection to the Hearing Officer. **Failure to appear will result in the assessment of all fines and penalties against you by default.** Filing an objection statement will suspend further accumulation of fines and/or penalties until such time as a final determination is made.
